

**St. Thomas More Parish School
Family Fundraising Agreement
School Year 2019-20**

The Minimum Family Fundraising Contribution amount has been set at **\$550 in profit** (Family Fundraising Dollars) for the 2019-20 school year. The following information shows the different methods available to families to achieve this commitment. Parents Club may add, change, or delete fundraising opportunities and will let you know the profit margin at that time.

| Fundraising Opportunity | Profit Margin | Example |
|--------------------------------|--|---|
| Magazine Sale | 45% | For every \$100 in sales, there is \$45 profit. |
| Mixed Bags | 40% to 50% depending on items | For every \$100 in sales, there is \$40-50 profit. |
| Wreath Sale | approximately \$10 per item (or \$5 if item is shipped directly as a gift) | For every item sold that is delivered for pick up at the school, there is \$10 in profit. |
| Scrip | average of 5% | For every \$100 of Scrip purchased, there is an average of \$5 in profit. |
| Mums/Easter Lilies | 50% | For every mum purchased, there is an average of \$10 in profit. |
| Ivar's Concessions | approximately \$50 per person | For every game worked, there is about \$50 in profit per person. |
| Cookie Dough | 40% | For every \$100 in sales, there is \$40 in profit. |
| Chocolate Sale | 50% | For every \$100 in sales, there is \$50 in profit. |
| Direct Contribution** | 100% | For every \$100 given to Parents Club, there is \$100 profit. |

** If you choose to satisfy part or your entire Minimum Family Fundraising Contribution amount through a direct contribution to Parents Club, one third of the direct contribution amount will be due on October 31, 2019, January 31, 2020, and April 30, 2020.
